Terms and Conditions

In signing this contract with the European Summer University Frankfurt, you are legally bound to the terms and conditions of this contract.

The course fee of **€ 550** includes

- Costs for lectures and workshop in Frankfurt
- (selected) travel costs to companies in Frankfurt region (we expect the students to use the Semesterticket or equivalent tickets)
- travel cost to Hamburg
- excursions in Hamburg
- accommodation in Hamburg (hostel; multi-bed rooms)
- selected public transport costs in Hamburg
- the social & cultural program
- farewell breakfast

The course fee will be billed to the applicant, after acceptance from the European Summer University 2017 management office.

Confirmation of Registration

The ESU Frankfurt Team will confirm your registration acceptance or rejection within three weeks after your application. We kindly ask you to pay the tuition at the latest two weeks after your acceptance to the ESU Frankfurt program.

Cancellations

If an accepted applicant wishes to withdraw from the program before program start, the applicant must state in writing his or her withdrawal to the European Summer University. A withdrawal will be effective from the date which the University receives the written confirmation. The University will attempt to reallocate your awarded position to someone else. Should the situation arise that the University cannot reallocate the position and should incur a financial loss due to your withdrawal; a cancellation fee will be levied depending on the timing of cancellation: If the withdraw from the program is

- less than 3 months, but more than 6 weeks prior to the program we must charge 30% of the course fee
- less than 6 weeks, but more than 3 weeks prior to the program we must charge 50% of the course fee.



If the withdraw from the program is within the last three weeks prior to the program we will charge 100 % of the course fee.

Important

Participants must obtain a valid visa (if necessary). For further information, please consult the German embassy in your home country about travel requirements to Germany. The Hessen International Summer University is not responsible for visa costs or costs involved with a denied visa.

Please note: Enrolment and Participation in the European Summer University Frankfurt does not require a student visa and enrolment does not provide sufficient means to request a student visa for the Federal Republic of Germany.

Frankfurt European Summer University's participants **will not** be enrolled as students of Frankfurt University of Applied Sciences.

The ESU Frankfurt Team reserve the right to cancel the program if less than 10 students have been accepted until June 30th, 2017. We will then proceed to a 100 % refund of the program fee.
